How Did AFP Calgary Begin? The Public Demand for Accountability

AFP Calgary & Area Chapter has had an impressive history of achievement over its 20 years since its establishment, but how did it all begin?

With apologies for exact dates and names, the author will rely heavily on recollections of the catalytic events that occurred that called us to action and led to the creation of what would become the Association of Fundraising Professionals Calgary & Area Chapter.

The situation was ripe in the final years of the 20th century in Calgary to form up. Sporadic meetings had been taking place in our community in the 1990s whereas interested fundraisers were feeling

each other out to determine "whom" we were and if there was interest in associating. Questions like, "Would it be safe to get together and share our practices with other "competitors" in the business?" "How many of us are there?" "What would be the mandate of such an organization?" and "What's in it for me/my employer?" may have been in the air.

A couple of significant developments occurred that triggered our Chapter's creation and made these questions moot. Indeed, we were propelled forward to create an organization for fundraisers in our community.

There was an establishing meeting that took place at the Southern Alberta

had nothing nice to say about professional fundraisers and the rules under which they operated. The interviewer probed for answers as to how a situation like this could happen. The "expert" was a trained lawyer and was the CEO of a Calgary-based consulting firm, assisting non-profits in starting up/stabilizing their operations. The expert operated a *percentage-based* fundraising business. She appeared to be highly credible.

Regardless of the content of the interview, a number of future founders of AFP asked themselves, "How is this person empowered to speak for *us*?" At the SAIT meeting, the situation was put on the table. There was unanimous consent that we, in the profession, must lead with appropriate messaging within the community about the way in which non-profits and professional fundraisers operate. "We" needed to be identified as the spokes agency and to speak for ourselves. However, by whom and how would we be empowered? Likely you can see where this is going.

Ms. Proulx was prepared to lead a team to form up and ultimately represent the sector in the community with the goal of instilling trust

To quote Edmund Burke, "Those who don't know history are doomed to repeat it." Perhaps more optimistically, we would be well advised to know our past, to honour where we have come from and to build on the shoulders of those who have come before us. AFP Calgary is committed to researching and developing our Chapter's roots and sharing the story with our members. We trust you approve. in and awareness of sector practices. At the meeting, she learned that another, Dree Thomson, had already begun the process of developing such an organization. Ms. Proulx was pleased to learn this and deferred to Ms. Thomson, who would go on to become the President of Calgary's first association of fundraising professionals.

Public outrage about this case would eventually place the issue on the laps of politicians in Edmonton whose solution was the development of legislation: the Alberta Fund-Raising Act. It was clear from the white paper that the fundraising profession was not well understood, or liked. Punitive restrictions/penalties proposed within

Institute of Technology's Penthouse and it was this moment in time that started it all. Elaine Proulx hosted the meeting. An interview she heard on CBC Radio the day before had riled her so much, she had called everyone on her rolodex. The room was full to capacity — on the order of 18-20 people attended. Leaders in the charitable community from the arts, health agencies, education and social agencies were there.

A little background to provide context: a scandal concerning a Calgary non-profit was on the front pages of the city's papers. In short, a non-profit agency's Executive Director had unilaterally taken funds from its operations and sent them to a fraudulent, off-shore operator. The ED was drawn to the promise of "beyond belief" returns on her investment that, in turn, would help her organization achieve its goals. It turned out to be a scam and the organization was facing intense media scrutiny and was on the verge of closing its doors. At the root of it all was the issue of the misuse of charitable donations.

It was this CBC interview concerning this scandal that had set Ms. Proulx off on the road to action. A so-called, "highly qualified representative from the non-profit sector" was being interviewed; she the legislation required, for example, that all professional fundraisers would have to post a \$25,000 cash bond with the government before commencing with any fundraising activities.

The proposed Act caused immediate and intense activity by a formative group of professionals in the community. Notably, Nancy Palmer and Stu Reid would lead a two-person charge, backed by our local board (all founders of the now AFP Calgary & Area Chapter) to lobby and inform government of the realities of fundraising in Alberta and North America. Alberta fundraisers now operate (or should be operating) under this legislation today. It was as a direct result of AFP Calgary & Area's formation and the fact that we had a *Code of Ethics and Standard of Practices* that the Act passed, de-barbed of many of its most punitive and ill-advised sections.

Rest assured, there will be more particulars about our very exciting and eventful roots in coming articles, leading up to our 20th Anniversary. Suffice to say, we owe a great deal to the early volunteers who put us on the map and to those who continue to lead the Calgary AFP Chapter.

We're proud to kick things off with Val Hoey, CFRE, who's currently on the search for new and interesting opportunities after a 30-year career in fundraising, including the last 14 years as Associate Vice-President of College Advancement at Bow Valley College.

Q: Val, you've had a long and impressive career. What do you like most about being a fundraiser?

"That is an interesting question, the challenge will be in how to distill the many aspects that for me make the profession of fundraising meaningful. I suspect I would land on two elements, firstly the people you meet and secondly the opportunity the profession provides by allowing you to buy mission which ultimately enriches community."

Q: What has been the biggest change you've seen in the profession over the decades?

"Again an interesting question. Technology, I believe has brought the profession and the professionals within the sector closer together providing collaborative opportunities across geographic boundaries instantly. The profession itself has continued to adapt in a meaningful and significant way which is reflective of the individuals within the sector who bring their experience, professionalism and intellectual capacity to a profession that is quite truly on the cutting edge of society. There is a level of sophistication that has evolved over the years reflected through the training programs and tools that are designed and delivered locally, nationally and internationally by members of the profession complimented with opportunities to pursue undergraduate or graduate degrees in the discipline of Philanthropy."

EMBER PROFILE - 20TH ANNIVERSAR

Q: Is there a story or experience that stands out for you as particularly meaningful or memorable? Why?

"For me it was the moment that I realized that fundraising was not solely about asking for money, that it was about an exchange of ideas, of values, of facilitating meaningful conversations that would create a better world. This was a pivotal moment of understanding that allowed me to build my career on building relationships that would ultimately buy more mission while also creating life-long relationships for the organizations that I represented."

Q: You've been a member of AFP for many years. What has membership in AFP meant to you, professionally and personally?

"I wish I had been a member of AFP Calgary when it began two decades ago. I was, however, one of the founding members of AFP Edmonton and then had the honour of being involved in AFP Calgary when I moved here 14 years ago. I would say membership in AFP has been critical in my career. It provided me with the opportunity to meet and collaborate with exceptional professionals in Canada and across the world. AFP brings together the best that the sector has to offer both in the opportunity to advance one's career and at the same time continue to personally grow in the knowledge of your profession. It provides a platform where individuals can be stimulated, challenged and continually grow in their knowledge while creating an opportunity to volunteer locally at their own chapter. One could say Membership is the first step towards Mentorship in AFP."

Q: What advice would you give more junior members who aspire to a career in fundraising like yours?

"Like any career, it is a professional journey and learning does not stop when you leave college or university and have finally landed that dream job. I would encourage junior members to embrace their life-long learning in the field of Philanthropy by engaging in meaningful conversations with other professionals, by always having one book on the go that they will learn from, by volunteering on a committee with AFP and by trusting their instincts when opportunities are placed in front of them but most of all I would encourage them to always start each day with the thought of "how can I make things better today?"

Highlights:

- On February 2, 2016, six new members were sworn in to Alberta's Cabinet, including a Minister designated exclusively to the Culture and Tourism portfolio. Other highlights of interest to the non-profit sector include the creation of the Alberta Climate Change Office, a renamed ministry and new Minister of Indigenous Relations, the naming of an Associate Minister of Health, as well as new Ministers for Service Alberta, Status of Women, and Seniors and Housing.
- March 2016 Alberta's privacy commissioner is seeking to bring all non-profit organizations under the Personal Information Protection Act, but some fear compliance with the law will put undue strain on their already limited resources. AFP shares CCVO's view, in their submission to the Standing Committee on Alberta's Economic Future, that PIPA be amended to apply fully to all nonprofit and charitable organizations and activities, subject to an 18-month transition period that includes training and education opportunities See full submission here: <u>http://www.calgarycvo. org/wp-content/uploads/2016/03/CCVO-PIPA-Review-Submission-FINAL.pdf</u>

Alberta Budget April 14, 2016 – Highlights

Although there were no direct charitable or giving implications in the NDP's second budget, a budget built on the assumption of an average WTI oil price of \$42, AFP Calgary members may be interested in this At-A-Glance recap.

- 2016 deficit projected at \$10.4 billion debt will rise to \$57.6 billion by 2019.
- Royalty revenues expected to drop by 90 per cent, to \$1.4 billion, in 2017 (a 40-year low).
- NDP recommitted to its \$34-billion, five-year infrastructure spending program.
- Small Business Tax Rate (revenue of \$500,000 or less) drops from three to two per cent; gives approximately \$865 million back to entrepreneurs over next five years.
- \$165 million in tax credits, including an investor tax credit, to encourage investment in small and medium-sized businesses and \$25 million in new funding to be invested through Alberta Enterprise Corporation to spur innovation.
- Carbon levies will be added to everything from gasoline to natural gas and propane. Levies on consumer goods will combine with the existing carbon tax on large emitters to raise \$9.6 billion over five years, which the government plans to spend on renewable projects, "green infrastructure" like public transit, and consumer rebates, including those to help low and middle-income Albertans deal with the price on carbon.
- No new taxes aside from the carbon tax.
- Bank of Canada Governor Stephen Poloz recently said the last federal budget – also highlighted by deficit spending – will boost national GDP by 0.5 per cent this year and 0.6 per cent next. This provincial budget will do something similar to provincial GDP.
- The NDP projects a balanced budget by 2024.

2016 Federal Budget - Impact on Registered Charities and Non-Profit Organizations

The Minister of Finance tabled the Government's 2016 Federal Budget on March 22, 2016. A few of the tax measures in Budget 2016 that impact registered charities are highlighted below. There are no new tax measures related to non-profit organizations (NPOs).

For Registered Charities, Budget 2016 Confirms:

- The Government's intention to proceed with the measure announced in Budget 2015 which allows registered charities to acquire or hold passive investments in limited partnerships.
- The Government's intention not to proceed with the measure announced in Budget 2015 that would provide an exemption from capital gains tax for certain dispositions of private company shares or real estate where cash proceeds from the disposition are donated to a registered charity within 30 days. The removal of this capital gains exemption will come as a disappointment for many in the charitable sector.
- That when a charity supplies property or services in exchange for a donation and when an income tax receipt may be issued for a portion of the donation, only the value of the property or services supplied will be subject to GST/HST. The proposal will ensure that the portion of the donation that exceeds the value of the property or services supplied is not subject to GST/HST. It also brings the GST/HST treatment of this type of exchange into line with the split-receipting rules under the Income Tax Act.
- The Government's commitment to review and clarify the rules governing political activities of charities. The CRA, in consultation with the Department of Finance, will engage with charities through discussions with stakeholder groups and an online consultation.

For Non-Profit Organizations

Once again, Budget 2016 was silent on the proposed consultation on the income tax exemption for NPOs (this was first announced in Budget 2014 when the Government intended to review whether the income tax exemption for NPOs remained properly targeted and whether sufficient transparency and accountability provisions were in place.) As part of the proposed review, the Government indicated that it would release a consultation paper for comment and further consult with stakeholders as appropriate. To date, nothing has been released and the status of the proposed consultation remains uncertain.

Annotated federal budget summaries focusing on charities and non-profits are available from Blumbergs, BLG, Carters, Miller Thomson LLP and others.

Bill C-239 – There is no formal AFP position as yet on Bill C-239 (Ted Falk - Fairness in Charitable Gifts) but AFP Canada's Government Relations Committee is monitoring. The bill would better enable registered Canadian charities to attract donations by providing the same favourable percentage of federal tax credits that a political donation would receive. As Private Members Bills are rarely passed into law, it will need to get further through the House before an official position will be taken. Our Canadian and America GR specialists had this to say, "It sounds promising, but the question is its viability, which is still murky due to a variety of factors including the potential cost (\$1.8 billion per year). Imagine Canada currently is neutral on it."

UPDATE: The Canada New Horizons Transition Task Force

A new AFP association governance structure is being considered for Canada. Below is an update on the plan and information on how all AFP Canada members can get involved.

The Canada New Horizons Transition Task Force continues to make steady progress toward implementation of an enhanced AFP presence for fundraising professionals in Canada. Recommendations to form a Canada-centric association and governance arm in Canada were presented last summer in Regina by the task force chair Denis Lalonde and unanimously approved by the AFP International Board of Directors in October.

Last week, the Transition Task Force convened in Toronto. Chaired by Nicholas Offord, the transition team includes Scott Decksheimer, CFRE, Patrick Feeley, CFRE, Michelle Gauthier, Denis Lalonde, Ken Mayhew, Marnie Spears, and Andrew Watt, FInstF.

Moving forward, the Transition Task Force will prepare a request for proposals (RFP) to identify a search firm to recruit a senior level staff person with a dual title: Executive Vice President of AFP and Executive Director of Canada. The position will report to the President & CEO of AFP with a dotted line to an AFP Canada Board, to be appointed separately.

The structure of that board is still under discussion. However, while a final governance model is being considered, it was decided that the Transition Task Force will serve as a nominating committee to recruit the first board chair. **In the coming weeks, all Canadian members will receive forms enabling their participation in the process of nominating candidates for the chair.**

The Transition Team will update and discuss the status of its work with the Canadian Chapter Leadership at the July retreat in Winnipeg. A formal implementation plan and schedule will be presented to the full AFP International Board in October.
